1. Introduction

1.1 The consideration of the Forward Plan is a standing item of the Joint Committee's agenda.

- 1.2 The Joint Committee has one more meeting scheduled within this current municipal year on 13 March 2025. New dates are proposed for the municipal year 2025/26.
- 2. Forward Plan of Agenda Items
- 2.1 An updated Forward Plan of Agenda Items for the scheduled meetings in 2025/26 has been prepared for consideration by the Joint Committee and is contained at Appendix A.
- 3. <u>Meeting Dates for 2025/26</u>
- 3.1 Clause 17 of the Joint Committee Agreement sets out the arrangements for meetings. The first meeting of the Joint Committee shall be the annual meeting for the year and thereafter the first meeting held after 1st April in any year shall be the annual meeting and the Joint Committee shall meet at least four times a year
- 3.2 The proposed dates for meetings of the Joint Committee are:
 - 26 June 2025
 - 11 September 2025
 - 11 December 2025
 - 12 March 2026

commencing at 2pm

- 3.4 All meetings of the Joint Committee have so far been held at the Chelmsford City Council offices. This venue seems to have worked well with free parking on-site and making it easier to provide the necessary legal and democratic support to the Committee. It is proposed that this arrangement continues for 2025/26.
- 4. <u>Conclusion</u>
- 4.1 The Joint Committee will meet at least four times in any one year and dates for the 2025/26 municipal year are proposed. A Forward Plan of Agenda Items has been prepared to ensure that the Joint Committee is fulfilling the requirements as set out in the Joint Committee Agreement.
